

Dear Commissioners:

On behalf of the Florida Association of Nurse Anesthesiology Political Committee ("FANA PAC" or "PAC"), I thank you for the opportunity to provide an explanation of the events that resulted in the late filing of Special Election Report SG2 2023 STR 118. As noted by our legal counsel in prior submissions, we seek relief from the \$4000 fine imposed by the Division of Elections as the late filing was caused by unusual or other circumstances.

The FANA PAC is an active and engaged political committee associated with the Florida Association of Nurse Anesthesiology ("FANA"). Since its inception in November 2021, the PAC has utilized its contracted legal and lobbying partners to assist with certain aspects of PAC operations, including the tracking and reporting of campaign contributions. Since 2021, the PAC has had an established process in place for the tracking and reporting of contributions. Until the late filing at issue in this matter, the process worked well, and all reports were timely filed. As discussed below, following the late filing in December 2023, the PAC modified its processes to address the issues that caused the late filing of the special election report.

It has been the PAC's longstanding preference for FANA or FANA PAC members to attend fundraising events and/or directly deliver contribution checks to candidates. In some cases, however, it is not feasible for a FANA or FANA PAC member to do so, and in those instances FANA's primary lobbying firm, Capital City Consulting ("CCC"), distributes the contribution check on the PAC's behalf. Occasionally, the PAC does not have sufficient time to issue and mail the contribution check to CCC before a fundraising event and in anticipation of those occasions, CCC maintains a small number of FANA PAC checks to use for PAC-approved contributions. Under the PAC's processes that were in place in November-December 2023, any time CCC issued a PAC check, CCC was required to notify the PAC chairman, FANA's legal partner, Rutledge Ecenia, P.A.,

and Computare Partners, the compliance consultant that handles the filing of the PAC's contribution reports with the Department of State ("Department"). Under the PAC's policy, CCC was to provide notice as soon as practicable, and the notice was to include the check number, date, amount, and the recipient of the check.

On November 14, 2023, CCC issued a FANA PAC contribution check for Mike Redondo's campaign in the special election for HD 118. CCC did not, however, report the contribution to the PAC, Rutledge Ecenia, or Computare Partners until December 6, 2023, five days after the filing deadline. Since the FANA PAC approved the Redondo contribution in a special PAC meeting shortly before CCC issued the check, CCC mistakenly believed the above-referenced notice requirements were unnecessary. When CCC ultimately reported the contribution, CCC did not identify it as a special election contribution, which further delayed Computare Partners' filing of the campaign treasurer's report. As soon as the special election contribution was identified as such, Computare Partners filed the report with the Department. Between November 14, 2023-December 5, 2023, CCC issued twenty-three contribution that CCC did not timely report to FANA and its partners.

The FANA PAC has since performed an in-depth review of its tracking and reporting processes and has modified them in an effort to prevent miscommunications and late filings in the future. Among other things, modifications include limiting the number of checks CCC issues, requiring same day notification when CCC issues a check, requiring contributions that have an expedited reporting deadline to be identified as such, and expanding the parties to whom notification is made. The FANA PAC and its partners are monitoring this process and if there are any concerns with its efficacy, issuance of the checks will be transferred to Rutledge Ecenia. Given the FANA PAC's record of timely filing all required reports (other than the report at issue), we believe this was a unique occurrence and that the new processes will successfully address the issues that caused the late filing.

The FANA PAC appreciates the importance of maintaining transparency in contributions to political campaigns and would note that Representative Redondo reported the PAC's contribution on November 17, 2023, thus the contribution was publicly available well before the December 5 special election and the December 9 filing by the PAC.

We believe the above facts demonstrate unusual or other circumstances that support waiver or reduction of the \$4000 fine imposed against the FANA PAC and respectfully request the commission consider the following mitigating factors:



- This is the PAC's first late filing;
- Since its inception, the FANA PAC has had processes in place in an attempt to ensure compliance with reporting requirements;
- The FANA PAC considers the late filing a serious matter and has amended its processes to ensure timely filing moving forward;
- The PAC's contribution was publicly available prior to the December 5 election by virtue of Representative Redondo's November 17 filing; and
- The \$4000 fine is quite high relative to the violation itself, especially in light of the above facts.

A special election has been called for the office of State Representative, District 118. The Special Primary Election is scheduled for October 3, 2023. The Special General Election is scheduled for December 5, 2023.

When a special election is called to fill a vacancy in office, all political committees, electioneering communication organizations, political parties and affiliated party committees <u>making</u> <u>contributions or expenditures to influence the results of such special election</u> shall file campaign treasurer's reports with the filing officer on the dates set by the Department of State.

Committees or organizations are required to file special election campaign treasurer's reports **only** if the committee or organization makes a contribution to a special election candidate during the special election reporting periods (see chart on next page) or makes an expenditure to influence the results of the special election.

Please note that activities reported on special election reports are <u>only expenditures</u> that are made to influence the results of the special election. <u>All other activity is reported on the appropriate quarterly report.</u>

Once a committee or organization has participated in the special election and has filed a special election campaign report, all remaining special election reports must be filed even if there is no further special election activity. If there is no activity, a waiver of report must be filed.

All reports must be filed through the Electronic Filing System (EFS) no later than midnight, Eastern Time, on the due date. Reports not filed by this time are late filed and subject to the penalties in Sections 106.07(8) and 106.29, Florida Statutes.

In the event the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

WHEREAS, pursuant to section 100.111(2), Florida Statutes, prior to setting the special election dates, the Governor shall consider any upcoming elections in the jurisdiction where the special election will be held.

NOW, THEREFORE, I, RON DESANTIS, as Governor of Florida, pursuant to my solemn constitutional duty to take care that the laws be faithfully executed, and pursuant to the Constitution and laws of the State of Florida, do hereby promulgate the following Executive Order, to take immediate effect: Section 1. A Special Election shall be held to fill the vacancy in the office of Florida House of Representatives, District 118.

Section 2. A Special Primary Election shall be held on October 3, 2023.

Section 3. A Special Election shall be held on December 5, 2023, if necessary, to select the Representative for House District 118.

Section 4. The Secretary of State shall work to implement the other scheduling requirements for this special election.

All reports must be completed and filed through the EFS no later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the

due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the reports or expenditures, whichever is greater, for the total receipts or expenditures, whichever is greater, for the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer, and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
