#### **CONSENT FINAL ORDER**

All Things Common PC ("Respondent") and the Florida Elections Commission ("Commission") agree that this Consent Order resolves all issues between the parties in this case. The parties jointly stipulate to the following facts, conclusions of law, and order:

#### FINDINGS OF FACT

1. On October 19, 2022, the Commission received a referral from the Division of Elections ("Division") alleging that Respondent violated Florida's election laws.

2. On December 4, 2023, the Commission entered an Order of Probable Cause finding there was probable cause to charge the Respondent with three counts of violating Section 106.19(1)(c), Florida Statutes.

3. Respondent has expressed a desire to enter into negotiations directed toward reaching a consent agreement.

4. Respondent and the staff stipulate to the following facts:

a. Respondent is a political committee registered with the Division.

b. Calvin Cobb served as Respondent's chairperson and treasurer from the committee's inception until May 16, 2023.

c. On June 13, 2023, the Division acknowledged the appointment of Carol McWilliams as the committee's new chairperson and Frances Buckner as the new treasurer.

d. Respondent failed to include required information in the 2022 P6, 2022 P7, and 2022 P7A Reports.

e. The committee's 2022 P6 Report was filed on January 12, 2023. Bank records reflected one contribution totaling \$95.84; however, Respondent reported one unverified expenditure totaling \$680.05.

f. The committee's 2022 P7 Report was filed on January 12, 2023. Bank records reflected six contributions totaling \$6,759.08 and 34 expenditures totaling \$1,803.76; however, Respondent reported three unverified expenditures totaling \$1,818.94.

g. Respondent filed a notice of no activity for the 2022 P7A reporting period on January 12, 2023. Bank records reflected 13 expenditures totaling \$1,922.98.

h. Respondent's current chairperson, Carol McWilliams, is actively addressing all outstanding fines and reporting issues she inherited from the committee's predecessors.

i. Ms. McWilliams provided receipts for money orders she obtained to resolve the outstanding automatic fines assessed for the 2022 P6 and 2022 P7 Reports.

j. Ms. McWilliams alleges that, because the committee currently has no funds, she is settling all outstanding fines from her personal funds.

#### **CONCLUSIONS OF LAW**

5. The Commission has jurisdiction over the parties to and subject matter of this cause, pursuant to Section 106.26, Florida Statutes.

6. The Commission staff and Respondent stipulate that staff could prove all the facts in paragraph four above by clear and convincing evidence and to the Commission's ability to impose a civil penalty in the case.

#### ORDER

7. Respondent and the staff of the Commission have entered into this Consent Order freely and voluntarily.

8. Respondent shall bear its own attorney's fees and costs that are in any way associated with this case.

9. The Commission will consider this Consent Order at its next available meeting.

10. Respondent voluntarily waives confidentiality upon approval of the Consent Order by the Commission, the right to any further proceedings under Chapters 104, 106, and 120, Florida Statutes, and the right to appeal this Consent Order.

11. This Consent Order is enforceable under Sections 106.265 and 120.69, Florida Statutes. Respondent expressly waives any venue privileges and agrees that, if enforcement of this Consent Order is necessary, venue shall be in Leon County, Florida, and Respondent shall pay all fees and costs associated with enforcement.

12. Payment of the civil penalty by cashier's check, money order good for at least 120 days, or attorney trust account check, is a condition precedent to the Commission's consideration of this Consent Order.

#### PENALTY

WHEREFORE, based upon the foregoing facts and conclusions of law, the Commission finds that Respondent violated Section 106.19(1)(c), Florida Statutes, and imposes a civil penalty in the amount of \$750.

Therefore, it is

**ORDERED** that Respondent shall remit to the Commission a civil penalty in the amount of **\$750**, inclusive of fees and costs. The civil penalty shall be paid by cashier's check, money order good for at least 120 days, or attorney trust account check. 

#### **ORDER OF PROBABLE CAUSE**

**THIS MATTER** was heard by the Florida Elections Commission ("Commission") at its regularly scheduled meeting on November 15, 2023, in Tallahassee, Florida.

On July 7, 2023, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violations:

#### Count 1:

On or around August 12, 2022, All Things Common PC violated Section 106.19(1)(c), Florida Statutes, when it deliberately failed to include information required by Chapter 106, Florida Statutes, on the committee's 2022 P6 Report.

#### Count 2:

On or about August 19, 2022, All Things Common PC violated Section 106.19(1)(c), Florida Statutes, when it deliberately failed to include information required by Chapter 106, Florida Statutes, on the committee's 2022 P7 Report.

#### Count 3:

On or about August 26, 2022, All Things Common PC violated Section 106.19(1)(c), Florida Statutes, when it deliberately failed to include information required by Chapter 106, Florida Statutes, on the committee's 2022 P7A Report.

The Commission finds that there is no probable cause to charge Respondent with violating

Section 106.07(7), Florida Statutes.

## NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing*. The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. #### STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.19(1)(c)**, **Florida Statutes**, and **no probable cause** to charge Respondent with violating **Section 106.07(7)**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on March 9, 2023, the following facts and law support this staff recommendation:

1. On October 19, 2022, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division"), alleging that All Things Common PC ("Respondent") violated Chapter 106, Florida Statutes.

2. Respondent is a political committee registered with the Division. (ROI Exhibit 13, page 2)<sup>1</sup> Respondent's Statement of Organization of Political Committee form was filed on September 21, 2021, which identified Calvin Cobb as the committee's chairperson and treasurer. (ROI Exhibit 2, pages 1-2)

3. By letter dated November 30, 2022, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because it had not received funds, made contributions, or expended reportable funds during the following reporting periods:

- 2022 P6
- 2022 P7
- 2022 P7A

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, may have falsely reported or deliberately

failed to include information required by Chapter 106, Florida Statutes, during the following reporting periods:

- 2022 P6
- 2022 P7
- 2022 P7A

4. By letter dated September 22, 2021, Donna S. Brown, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received its Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees form and that the name of the organization was placed on the active committee list. (ROI Exhibit 3, page 1)

5. The acknowledgment letter advised Respondent that all political committees filing reports with the Division are required to use the electronic filing system ("EFS") and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all the Division's publications and reporting forms were available on its website and directed Respondent to print out the *Calendar of Reporting Dates* as well as other relevant documents. (ROI Exhibit 3, page 2)

6. Respondent's 2022 P6 Report was due on August 12, 2022, its 2022 P7 Report was due on August 19, 2022, and its 2022 P7A Report was due on August 26, 2022. (ROI Exhibit 4, pages 1-3; ROI Exhibit 7, page 1) However, Respondent failed to timely file the reports or notify the filing officer that no reports would be filed. *See* Compl.

7. By letters dated August 15, 2022, August 22, 2022, August 29, 2022, September 23, 2022, and September 26, 2022, the Division notified Respondent that its reports had not been received. (ROI Exhibits 4-6; ROI Exhibit 13, pages 3-4) The letters also notified Respondent that it was still required to notify the Division if it had no reportable financial activity during the relevant reporting periods. (ROI Exhibits 4-6) The final notification letters were confirmed delivered on September 28, 2022. (ROI Exhibit 5, page 3; ROI Exhibit 6, page 2)

8. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any financial activity occurred during the relevant reporting periods, i.e., July 30, 2022, through August 5, 2022, August 6, 2022, through August 18, 2022, and August 19, 2022. (ROI Exhibit 5, pages 1-2; ROI Exhibit 6, page 1)

9. As to the 2022 P6 reporting period, Respondent's bank records reflect one contribution totaling \$95.84. (ROI Exhibit 8, page 1)

10. Respondent filed the 2022 P6 Report 153 days late on January 12, 2023. (ROI Exhibit 7, page 1; ROI Exhibit 9, page 6) Respondent disclosed one expenditure totaling \$680.05, which was not verified by the committee's bank records. (ROI Exhibit 8, page 1; ROI Exhibit 9, page 3) As of July 6, 2023, Respondent has not corrected the report. (Attachment A, page 2)

11. As to the committee's 2022 P7 Report, Respondent's bank records reflect six contributions totaling \$6,759.08 and 34 expenditures totaling \$1,803.76. (ROI Exhibit 8, pages 1-5)

12. Respondent filed the 2022 P7 Report 146 days late on January 12, 2023. (ROI Exhibit 7, page 1; ROI Exhibit 10, page 6) Respondent disclosed three expenditures totaling \$1,818.94, which were not verified by the committee's bank records. (ROI Exhibit 8, pages 1-5; ROI Exhibit 10, page 3) One expenditure to Quiones Chisolm was incorrectly recorded as \$1,600.00 instead of \$300.00. As of July 6, 2023, Respondent has not corrected the report. (Attachment A, pages 2-3)

13. As to the committee's 2022 P7A Report, Respondent's bank records reflect 13 expenditures totaling \$1,922.98. (ROI Exhibit 8, pages 5-6)

14. Respondent filed a notice of no activity for the 2022 P7A reporting period 139 days late on January 12, 2023. (ROI Exhibit 7, page 1; ROI Exhibit 11, pages 1 & 6) As of July 6, 2023, Respondent has not corrected the submission. (ROI Exhibit 7, page 2; Attachment A, page 1)

15. Respondent's chairperson and treasurer, Calvin Cobb, stated that the committee was supposed to be closed due to him notifying the Division by email and letter. He stated that he moved to Virginia, but mail was still forwarded to his new address. When he initially started filing reports, Mr. Cobb received assistance from a friend who previously worked as a treasurer; however, the reports became backlogged when she stopped assisting him. He thought he filed all the reports, but it was later discovered that he failed to hit the submit button. He stated that he requested assistance from the Division at the beginning of the year. (ROI Exhibit 12, page 2)

16. According to the Division's records, Respondent is still an active political committee, and there is no record of Mr. Cobb notifying the Division that the committee had disbanded. (ROI Exhibit 13) The Division's history notes show that staff attempted unsuccessfully to reach Mr. Cobb by phone several times in November 2022. Mr. Cobb called and spoke with Division staff in January 2023 about the reports. (ROI Exhibit 13, page 5)

17. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).

18. The facts set forth above show that Respondent is a political committee registered with the Division. Respondent failed to timely file its 2022 P6, 2022 P7, and 2022 P7A Reports or notify the filing officer that no report would be filed. As it appears that Respondent had financial activity during the relevant reporting periods, Respondent failed to include information in its 2022 P6, 2022 P7, and 2022 P7A Reports in violation of Section 106.19(1)(c), Florida Statutes. Thus,

Respondent was not required to notify the filing officer that it would not be filing its reports because Respondent had reportable financial activity.

Based upon these facts and circumstances, I recommend that the Commission find **no probable cause** to charge Respondent with violating **Section 106.07(7)**, **Florida Statutes**, and find **probable cause** to charge Respondent with violating the following:

#### Count 1:

On or around August 12, 2022, All Things Common PC violated Section 106.19(1)(c), Florida Statutes, when it deliberately failed to include information required by Chapter 106, Florida Statutes, on the committee's 2022 P6 Report.

#### Count 2:

On or about August 19, 2022, All Things Common PC violated Section 106.19(1)(c), Florida Statutes, when it deliberately failed to include information required by Chapter 106, Florida Statutes, on the committee's 2022 P7 Report.

#### Count 3:

On or about August 26, 2022, All Things Common PC violated Section 106.19(1)(c), Florida Statutes, when it deliberately failed to include information required by Chapter 106, Florida Statutes, on the committee's 2022 P7A Report.

## I. Preliminary Information:

1. Respondent is a political committee registered with the Division.

2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 6) was filed on September 21, 2021. Calvin Cobb was appointed as campaign treasurer. To review the DS-DE 6, refer to Exhibit 1.

3. A Statement of Organization (DS-DE 5) for the political committee was filed with the Division on September 21, 2021. To review the Statement of Organization, refer to Exhibit 2.

4. An acknowledgement letter was mailed to the address provided on the DS-DE 5 on September 22, 2021, advising Respondent that all political committees filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing access to the EFS.

5. The acknowledgement letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Political Committee Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. 6. The Division sent correspondence to the address provided on the DS-DE 6 notifying Respondent that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2022 P6, 2022 P7, and 2022 P7A. The letter(s) included reference to the filing date(s) for the report(s). To review the failure to file correspondence, refer to Exhibit 4.

7. On September 23, 2022, the Division sent letters marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 6 notifying Respondent that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2022 P7 and 2022 P7A. The letters were confirmed delivered on September 28, 2022. To review the letters marked "Final Notice" and delivery confirmation, refer to Exhibit 5.<sup>1</sup>

8. 10. Respondent did not respond to the referral.

11. On March 2, 2023, I called Respondent's Chairperson, Calvin Cobb, for the purpose of providing an opportunity to discuss the allegations made in the referral. Mr. Cobb stated that the committee was supposed to be closed because he notified the Division of Elections by mail and email. He stated that when he initially got started filing reports, he had assistance from a friend that had previously worked as a treasurer. However, the reports became backlogged when she stopped assisting him. Mr. Cobb stated that he thought that he had filed all of the reports, but it was later discovered that he had failed to hit the submit button to complete the submissions. He stated that he contacted the Division of Elections in the beginning of 2023 for assistance in filing the reports. Mr. Cobb stated that he did download the election documents when he initially opened the committee. To review the phone log, refer to Exhibit 12.

due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the reports or expenditures, whichever is greater, for the period covered by the late report.

## Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer, and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

Dear Mr. Cobb:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was August 12, 2022.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
  - \$50 per day for the first 3 days late
    \$500 per day for each day after the 3rd day late
    If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. On October 19, 2022, the Florida Elections Commission received a complaint alleging that your committee violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because it had not received funds, made contributions, or expended reportable funds during the following reporting periods:

- 2022 P6
- 2022 P7
- 2022 P7A

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, may have falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, during the following reporting periods:

- 2022 P6
- 2022 P7
- 2022 P7A

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge, the Respondent, with violating Chapters 104 or 106, Florida Statutes.

You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed upon your committee. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.

#### Please note that all documents related to this matter will be mailed to the above address unless you notify us of a new address.

Pursuant to Section 106.25, Florida Statutes, complaints, investigations, investigative reports, and other documents relating to an alleged violation of Chapters 104 or 106, Florida Statutes, are <u>confidential</u> until the Commission finds probable cause or no probable cause, unless the Respondent files a written waiver of confidentiality with the Commission. The confidentiality provision does not apply to the Complainant or the Respondent.

Should you retain counsel, your attorney must file a notice of appearance with the Commission before any member of the commission staff can discuss this case with him or her.
