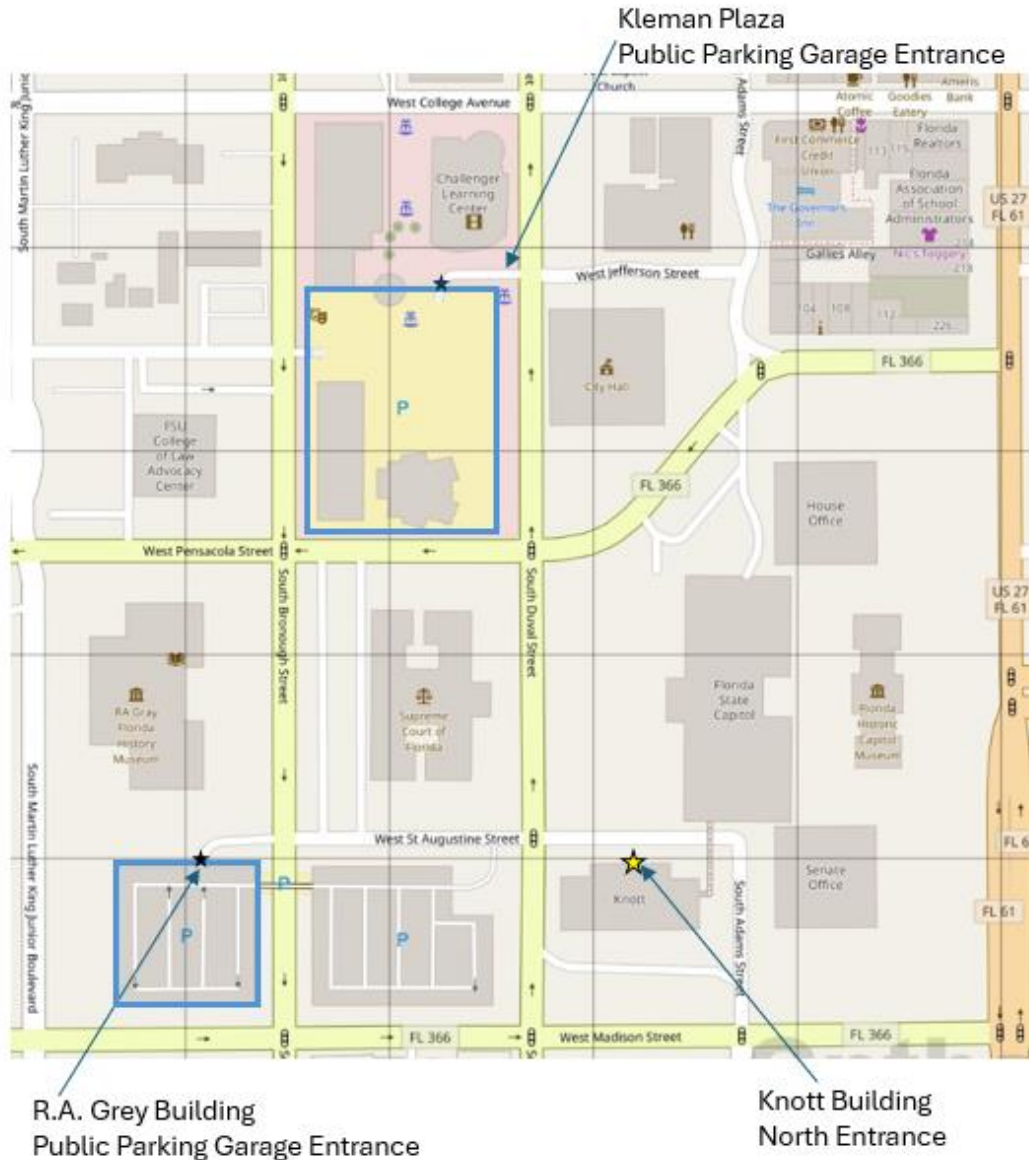

ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on February 7, 2024, in Tallahassee, Florida.

On December 28, 2023, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 M1 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 2:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P3 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 3:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P4 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 4:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P5 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 5:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P6 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 6:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P7 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 7:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 G1 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by consent order where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an informal hearing held before the Commission, if you do not dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a formal hearing held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-

hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within 30 days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. The date this order was filed appears in the upper right-hand corner of the first page of the order.

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(2)(b)1., Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on December 4, 2023, the following facts and law support this staff recommendation:

1. On June 27, 2023, the Florida Elections Commission (“Commission”) received a referral from the Department of State, Division of Elections (“Division” or “Complainant”), alleging that Drake Wuertz (“Respondent”) violated Chapter 106, Florida Statutes.

2. Respondent was a 2022 candidate for State Representative, District 38. (ROI Exhibit 1, page 2)¹ On April 7, 2022, Respondent changed his designation from State Representative, District 30, to State Representative, District 38.

3. By letter dated August 14, 2023, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2022 candidate for State Representative, District 38, acting as his own treasurer, failed to timely make necessary amendments to the campaign treasurer’s reports, as alleged in the complaint:

- 2022 M1
- 2022 P3
- 2022 P4
- 2022 P5
- 2022 P6
- 2022 P7
- 2022 G1

4. On August 10, 2021, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form (“DS-DE 9”) appointing himself as treasurer for his campaign. (ROI Exhibit 1, page 1)

¹ The Report of Investigation is referred to herein as “ROI.”

5. By letter dated July 27, 2021, Donna S. Brown, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that his name was placed on the 2022 active candidate list. (ROI Exhibit 2, page 1)

6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (“EFS”) and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 2, page 1) The letter further advised Respondent that all of the Division’s publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 2, page 2)

7. The campaign’s 2022 M1, 2022 P3, 2022 P4, 2022 P5, 2022 P6, 2022 P7, and 2022 G1 reports were incomplete when filed. *See Compl.*

8. The Division sent three letters notifying Respondent that the campaign’s reports were incomplete and that Respondent was required to amend the reports within 7 days of receipt of the notification. A Compliance Report showing why the reports were incomplete was attached to each notification. (ROI Exhibits 3 & 4) The final notification was confirmed delivered. (ROI Exhibit 4, page 8)

9. Respondent was given multiple opportunities to respond to Commission staff’s investigation, but failed to do so. (ROI, pp. 1-2, ¶¶7-8; ROI Exhibit 6)

10. “Probable Cause” is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).

11. The facts set forth above show that Respondent was a 2022 candidate for State Representative, District 38. Respondent failed to timely file the required amendments to the campaign’s 2022 M1, 2022 P3, 2022 P4, 2022 P5, 2022 P6, 2022 P7, and 2022 G1 reports within 7 days of receiving notification from the Division that the reports were incomplete and required amendment.

Based upon these facts and circumstances, I recommend that the Commission find **probable cause** to charge Respondent with violating the following:

Count 1:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign’s 2022 M1 Report within seven days

after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 2:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P3 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 3:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P4 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 4:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P5 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 5:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P6 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 6:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 P7 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 7:

On or about April 1, 2023, Drake Wuertz violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2022 G1 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

I. Preliminary Information:

1. I investigated whether Respondent violated this section of the election laws by failing to file amended report(s) for the following campaign treasurer report(s) after receiving notice from the filing officer: 2022 M1, 2022 P3, 2022 P4, 2022 P5, 2022 P6, 2022 P7, and 2022 G1.

2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on August 10, 2021. Respondent was appointed as campaign treasurer for Drake Wuertz, a 2022 candidate for State Representative, District 30. Respondent subsequently redesignated the office sought to District 38, and he filed another DS-DE 9 appointing himself as campaign treasurer on April 7, 2022. To review the DS-DE 9s, refer to Exhibit 1.

3. On July 27, 2021, the Division sent Respondent a letter acknowledging Respondent's appointment as the campaign treasurer for Drake Wuertz's campaign. The letter advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 2.

II. Alleged Violation of Section 106.07(2)(b)(1), Florida Statutes:

4. The Division sent correspondence to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The correspondence included error report(s) referencing the following report(s): 2022 M1, 2022 P3, 2022 P4, 2022 P5, 2022 P6, 2022 P7, and 2022 G1. To review the correspondence and error report(s), refer to Exhibit 3.

5. On March 22, 2023, the Division sent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The letter included an error report referencing the following report(s): 2022 M1, 2022 P3, 2022 P4, 2022 P5, 2022 P6, 2022 P7, and 2022 G1. It was confirmed delivered on March 25, 2023. To review the "Final Notice," error report and delivery confirmation, refer to Exhibit 4.

6. As noted above, the "Final Notice" was confirmed delivered on March 25, 2023. The Division filed the referral on June 27, 2023. By filing the referral, the Division affirmed that as of that date, the report(s) at issue had not been amended to correct all errors identified by the Division. To review the report(s) at issue, refer to Exhibit 5.

7. Respondent did not respond to the referral.

8. I attempted to contact Respondent on seven occasions for the purpose of providing an opportunity to discuss the allegations made in the referral. As of the date of this report, my telephone calls have been returned. Respondent replied to emails I sent him by providing an updated telephone number, which I called multiple times. He did not return my telephone calls. Therefore, I am unable to ascertain whether Respondent has read Chapter 106, Florida Statutes, and/or the *Candidate and Campaign Treasurer Handbook*. To review the phone log and emails, refer to Exhibit 6.

On June 27, 2023, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violation:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2022 candidate for State Representative, District 38, acting as his own treasurer, failed to timely make necessary amendments to the campaign treasurer's reports, as alleged in the complaint:

- 2022 P7
- 2022 G1

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violation occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are
