If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

**ORDER OF PROBABLE CAUSE**

**THIS MATTER** was heard by the Florida Elections Commission (“Commission”) at its regularly scheduled meeting on February 7, 2024, in Tallahassee, Florida.

On December 28, 2023, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff’s Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff’s Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation:

**Count 1:**

On January 31, 2021, Andy Mele violated Section 106.07(5), Florida Statutes, when he certified that the campaign’s 2021 Termination Report was true, correct, and complete when it was not.

The Commission finds that there is **no probable cause** to charge Respondent with violating Sections 106.141(1) and 106.19(1)(c), Florida Statutes.

### NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by consent order where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an informal hearing held before the Commission, if you do not dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a formal hearing held before an administrative law judge in the Division of Administrative Hearings (“DOAH”), if you dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within thirty (30) days of the date this Order of

Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. The date this order was filed appears in the upper right-hand corner of the first page of the order.

**STAFF RECOMMENDATION FOLLOWING INVESTIGATION**

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(5), Florida Statutes**, and **no probable cause** to charge Respondent with violating **Sections 106.141(1) and 106.19(1)(c), Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on May 16, 2023, the following facts and law support this staff recommendation:

1. On July 13, 2021, the Florida Elections Commission (“Commission”) received a referral from the Florida Division of Elections (“Complainant” or “Division”) alleging that Andy Mele (“Respondent”) violated Chapter 106, Florida Statutes.

2. Respondent was a 2020 candidate for State Representative, District 71. (ROI Exhibit 2, page 1)<sup>1</sup> Respondent was a first-time candidate and was defeated in the general election. (ROI Exhibit 7, page 2; ROI, page 1, ¶1; Attachment A, page 1)

3. Respondent’s Statement of Candidate form (“DS-DE 84”) and Appointment of Campaign Treasurer and Designation of Campaign Depository form (“DS-DE 9”) were filed on May 22, 2020. (ROI Exhibits 1 & 2) Respondent appointed himself to serve as treasurer for the campaign. (ROI Exhibit 1, page 1)

4. By letter dated September 10, 2021, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

**Section 106.07(5), Florida Statutes:** Respondent, a 2020 candidate for State Representative, District 71, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, based upon a surplus balance after the 2021 TR was filed, as alleged in the complaint.

**Section 106.141(1), Florida Statutes:** Respondent, a 2020 candidate for State Representative, District 71, filed a 2021 TR that may have failed to accurately reflect the disposition of all remaining campaign funds, based upon a surplus balance after the 2021 TR was filed, as alleged in the complaint.

**Section 106.19(1)(c), Florida Statutes:** Respondent, a 2020 candidate for State Representative, District 71, may have falsely reported or deliberately failed to include information in one or more campaign treasurer reports, as required by Chapter 106, Florida Statutes, based upon a surplus balance after the 2021 TR was filed, as alleged in the complaint.

5. By letter dated May 22, 2020, Donna S. Brown for Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2020 active candidate list. (ROI Exhibit 3, page 1)

6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (“EFS”), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all the Division’s publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 3, page 2)

**Alleged Violation: Section 106.07(5), Florida Statutes**

7. Complainant alleged that Respondent violated Florida’s election laws by certifying that the campaign’s 2021 Termination Report was true, correct, and complete when it was not based upon an apparent surplus balance.

8. Under Section 106.07, Florida Statutes, a campaign treasurer’s report is required to contain all contributions received and all expenditures made during the reporting period.

9. Respondent filed his 2021 Termination Report one day early on January 31, 2021. (ROI Exhibit 4, page 1) Respondent reported seven contributions totaling \$1,191.55 and five expenditures totaling \$12,581.26. (ROI Exhibit 6, pages 2-3)

10. Respondent filed an amended report on April 9, 2021, wherein he modified all contributions to reflect different dates and contributor types. (ROI Exhibit 6, page 2)

11. A subpoena was issued to Respondent’s designated campaign depository to verify the financial activity that occurred during the relevant reporting period, i.e., October 30, 2020, through January 31, 2021. (ROI Exhibit 6, page 1)

12. Bank records show that Respondent omitted six expenditures totaling \$564.31. (ROI Exhibit 5, pages 9, 11, 19, 22, 23, 25 & 27; ROI Exhibit 6, page 3)

13. Respondent stated that, although he appointed himself treasurer, he relied on Mindy LaCroix to file the campaign’s reports. Respondent stated that Ms. LaCroix volunteered to assist with the treasurer function for Respondent’s campaign. Though he never met her in person, Respondent stated that he provided Ms. LaCroix with spreadsheets on the campaign’s finances.

Respondent stated that he was unable to reach Ms. LaCroix during the relevant time frame and later discovered that she had been ill with Covid for several months. Respondent asserted that Ms. LaCroix never told him she was ill and did not return his calls or emails. Respondent acknowledged printing out and reading both Chapter 106, Florida Statutes, and the *Candidate and Campaign Treasurer Handbook*. (ROI Exhibit 7, pages 2-3)

14. As of December 26, 2023, Respondent has not corrected the 2021 Termination Report. (Attachment B, page 6)

15. Respondent certified that the campaign's 2021 Termination Report was true, correct, and complete when it was not.

**Alleged Violation: Section 106.141(1), Florida Statutes**

16. Complainant alleged that Respondent violated Florida's election laws by failing to properly dispose of the funds on deposit in his campaign account.

17. On November 3, 2020, Respondent was defeated in the 2020 general election. (ROI, page 1, ¶1; Attachment A, page 1) Therefore, Respondent was no longer permitted to accept contributions during the termination reporting period and was required to dispose of the funds on deposit in his campaign account within 90 days after being defeated, i.e., February 1, 2021. (ROI Exhibit 4, page 1)

18. Bank records show that Respondent received eight contributions totaling \$1,201.55 during the termination reporting period. (ROI Exhibit 5, pages 3 & 8) One contribution was reported on the prior reporting period, and the remaining contributions were either automatic deposits from online fundraising platforms or were checks issued prior to Respondent's defeat. (ROI Exhibit 5, pages 3, 8, 11-17; Attachment B, page 5) The account ended with a deficit balance of -\$17.00; however, the account reflected a zero balance until an automatic bank fee was assessed on the final day of the reporting period. (ROI Exhibit 5, page 24-28)

19. Respondent reported to the Division that any contributions received after the deadline had been committed and budgeted before the deadline and were needed to ensure that final expenses were covered. (ROI Exhibit 8, page 1)

20. It does not appear that Respondent willfully accepted contributions following his defeat or willfully failed to dispose of the funds on deposit in his campaign account within 90 days after being defeated.

**Alleged Violation: Section 106.19(1)(c), Florida Statutes**

21. Complainant alleged that Respondent violated Florida's election laws by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes, on the campaign's 2021 Termination Report.

22. Insufficient evidence exists showing that Respondent deliberately concealed or falsified the campaign's financial activity. The activity that was not initially disclosed was proper, and the activity that may have been improper, i.e., Respondent accepting contributions after his defeat, was timely and accurately disclosed.

23. It does not appear that Respondent falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2021 Termination Report.

24. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).


25. The facts set forth above show that Respondent was a candidate for State Representative, District 71, in the 2020 election. Respondent certified that the campaign's 2021 Termination Report was true, correct, and complete when it was not. It does not appear that Respondent willfully failed to dispose of the funds on deposit in his campaign account within 90 days after being defeated. It does not appear that Respondent falsely reported or deliberately failed to include required information on the campaign's 2021 Termination Report.

Based upon these facts and circumstances, I recommend that the Commission find **no probable cause** to charge Respondent with violating **Sections 106.141(1) and 106.19(1)(c), Florida Statutes**, and that the Commission find **probable cause** to charge Respondent with violating the following:

**Count 1:**

On January 31, 2021, Andy Mele violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2021 Termination Report was true, correct, and complete when it was not.

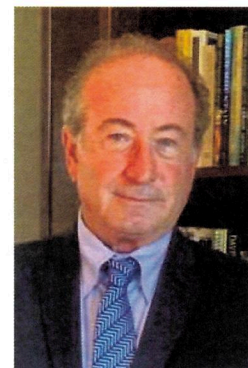

**I. Preliminary Information:**

1. Respondent was a 2020 candidate for State Representative, District 71; he was defeated in the general election held on November 3, 2020. Respondent was a first-time candidate.

2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on May 22, 2020. Respondent was appointed as campaign treasurer. To review the DS-DE 9, refer to Exhibit 1.<sup>1</sup>

3. Respondent filed a Statement of Candidate with the Division on May 22, 2020, in which Respondent certified he had been provided access to read and understand the requirements of Chapter 106, F.S. To review the Statement of Candidate, refer to Exhibit 2.

4. An acknowledgement letter was mailed to the address provided on the DS-DE 9 on May 22, 2020. The letter advised Respondent that all candidates filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing access to the EFS.

5. The acknowledgement letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 3.

**II. Alleged Violation of Section 106.141(1), Florida Statutes:**

6. I investigated whether Respondent violated this section of the election laws by not disposing of all remaining campaign funds within 90 days of being eliminated. To review Respondent’s filing history, refer to Exhibit 4.

7. On the date the 2021 TR was due, campaign account records reflect that the balance was -\$17.00.<sup>2</sup> To review the relevant bank statement, refer to Exhibit 5, pages 24-28.

**III. Alleged Violation of Sections 106.07(5), 106.141(1), and 106.19(1)(c), Florida Statutes:**

8. I investigated whether Respondent violated these sections of the election laws by certifying that one or more campaign treasurer report(s) were true, correct, and complete when they were not, falsely reporting or deliberately failing to include information in one or more campaign treasurer report(s), and failing to accurately reflect disposition of all remaining campaign funds in a termination report due to an apparent surplus balance after the 2021 TR was filed.


9. I reviewed bank records from the designated campaign depository and compared them with campaign treasurer report covering the following reporting period: 2021 TR.<sup>3</sup> The results of my review are reflected in the table below. To review the filing history, refer to Exhibit 4. To review the bank records, refer to Exhibit 5. To review the campaign treasurer report, refer to Exhibit 6.

10. Respondent did not respond to the referral.			
<p>11. I called Respondent for the purpose of providing an opportunity to discuss the allegations made in the referral. Respondent acknowledged that he appointed himself treasurer but stated it was because he did not have anyone else to appoint. However, Respondent stated that he relied upon Mindy LaxCroix as an acting treasurer to make timely reports. Though he never met her in-person, Respondent stated that he provided Ms. LaCroix with spreadsheets on his campaign’s finances. Respondent explained that he was unable to reach Ms. LaCroix during the relevant timeframe, and he later discovered that she had been ill with COVID for three months. Respondent asserted that Ms. LaCroix never told him she was ill and did not return calls or emails, but it appeared to Respondent that she was filing campaign treasurer’s reports for him. Respondent further stated that he sent bank statements to the Division to show there was no surplus in the campaign account. Respondent acknowledged printing out and reading both Chapter 106, Florida Statutes and the <i>Candidate and Campaign Handbook</i>. To review the phone log, refer to Exhibit 7.</p>			
<p>12. As noted in his interview, Respondent filed a letter with the Division in which he asserted that he did not have a surplus in his campaign account and that there was a zero balance in January. The letter and bank statements from his campaign account were filed with the Division on April 5, 2021. Respondent informed the Division that his “acting treasurer,” Ms. LaCroix, became ill with COVID but did not inform him and, “...she clearly was inconsistent with filing my campaign reports, which I sincerely regret.” Attached to his letter was a letter signed by Ms. LaCroix confirming that she volunteered to assist with the treasurer function for Respondent’s campaign. Ms. LaCroix stated that she was diagnosed with COVID in August 2020, and she was not clear of it until November 2020. She indicated that while hospitalized she was unable to take care of any work. Respondent filed another letter with the Division on May 13, 2021, in which he reiterated that Ms. LaCroix, who was “acting treasurer for the campaign,” became ill during much of his campaign without his knowledge. - Have you ever run for public office? If so, please name each office you ran for and state what year each election occurred.
  - No; Respondent has never run for public office.
- Have you ever been appointed to act as a campaign treasurer for a candidate? If so, please name each such candidate, the office each ran for, and state what year each election occurred.
  - No; Respondent has never acted as campaign treasurer.
- Have you ever held the office of chairperson, treasurer, or other similar position for a political committee or electioneering communications organization? If so...
  - No.
- Have you ever prepared or signed a campaign treasurer's report? If so, please state the name of the candidate or committee whose report you prepared or signed.
  - No; Respondent indicated that he had never prepared/filed a campaign treasurer's report.
- Do you possess a copy of Chapter 106, Florida Statutes? If so, when did you first obtain it? Have you read it?
  - Yes; Respondent stated that he printed this out and reviewed it.
- Do you possess a copy of the *Candidate and Campaign Treasurer Handbook*? If so, when did you first obtain it? Have you read it?
  - Yes; Respondent stated that he printed out the handbook and reviewed it.
- Why did you decide to act as your own campaign treasurer?
  - Respondent indicated that, at the time he filed qualifying documents, he didn't have anybody else to appoint as treasurer.

- Did anyone assist you in completing and/or filing campaign reports? [At this point in the interview, Respondent provided a brief narrative about the situation surrounding his “acting” campaign treasurer, Mindy LaCroix.]
  - Respondent stated that a campaign contributor recommended Mindy LaCroix; he was told that she had been a treasurer for someone else. “She came with a great recommendation.”
  - Respondent indicated that he never met with Ms. LaCroix in-person and did not officially add her name to the DS-DE 9 form (as his campaign treasurer). However, he stated: “I relied upon her to make timely reports, provided her with spreadsheets, incoming expenses...” Later, “it turned out that she got Covid, but she was a long-hauler and sick for 3 months.”
  - During this time, Respondent was unable to reach Ms. LaCroix. She never told Respondent that she was ill; she never returned calls or emails. Based on Respondent’s statements, it appears that she was completing 1 or 2 entries per campaign reporting period. Respondent stated that it appeared to him that she was filing campaign reports.
- Did you use any online contribution platforms?
  - Yes, Respondent used ActBlue and something else (he didn’t recall the name). He explained that, “it took a while for ActBlue to get things together.” In the interim, Respondent used the contribution platform that came with his website software package.
  - I requested that Respondent provide the itemized statements for online contributions for the 2021 TR reporting period. He stated that he’ll look for these and try to provide them.
- What steps have you taken to amend the 2021 TR?
  - Respondent indicated that he was not aware of any deficit balance.
  - At this point, we also discussed the original \$15,526.21 surplus cited in the original referral; we discussed that this arose because of duplicate entries and issues with reconciling bank accounts and online contributions.
- Do you have anything else to add for the Commission’s consideration regarding the charges specified in the letter of legal sufficiency in this case?
  - Respondent spoke further about the situation with “acting” treasurer, Mindy LaCroix. He stated that she ultimately wound up in the hospital, but nobody told him. He also stated: “It’s my fault for not being closer to it [role of campaign treasurer].”
  - Respondent reiterated that he sent (redacted) bank statements to the Division to show there was neither surplus nor deficit in 20201 TR period. It shows \$0 at closing date.

I have emailed the request to their sales department, hoping they pay a little closer attention to their emails.

I hope this clears things up. I will email the address for Stripe as soon as I get it.

Dear Mr. Mele:

On July 13, 2021, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

**Section 106.07(5), Florida Statutes:** Respondent, a 2020 candidate for State Representative, District 71, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, based upon a surplus balance after the 2021 TR was filed, as alleged in the complaint.

**Section 106.141(1), Florida Statutes:** Respondent, a 2020 candidate for State Representative, District 71, filed a 2021 TR that may have failed to accurately reflect the disposition of all remaining campaign funds, based upon a surplus balance after the 2021 TR was filed, as alleged in the complaint.

**Section 106.19(1)(c), Florida Statutes:** Respondent, a 2020 candidate for State Representative, District 71, may have falsely reported or deliberately failed to include information in one or more campaign treasurer reports, as required by Chapter 106, Florida Statutes, based upon a surplus balance after the 2021 TR was filed, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25, Florida Statutes, complaints, investigations, investigative reports, and other documents relating to an alleged violation of Chapters 104 or 106, Florida Statutes, are confidential until the Commission finds probable cause or no probable cause, unless the Respondent files a written waiver of confidentiality with the Commission. The confidentiality provision does not apply to the Complainant or the Respondent.

Should you retain counsel, your attorney must file a notice of appearance with the Commission before any member of the commission staff can discuss this case with him or her.
